TO PARENTS OF STUDENTS ATTENDING West Oso ISD:

Under the No Child Left Behind (NCLB) Act of 2001, a Title I, Part A-funded local education agency (LEA), or school district, that has not met AYP for two or more consecutive years in the same indicator (reading, mathematics, attendance rate, or graduation rate) is subject to LEA-level Title I School Improvement Requirements. Based on the 2010 LEA AYP Status released August 5, 2010, West Oso ISD is subject to the LEA-level School Improvement Program (SIP) requirements for Stage 1-Math and Reading for the 2010-2011 school year.

The NCLB statute requires the district to notify you of this status and to provide you with the following information. Please be advised that the district has the opportunity to appeal this district improvement designation. However, the requirements described in this letter must be implemented for the entire school year, regardless of the outcome of the appeal.

Within three months after being identified for improvement, an LEA must develop or revise its district improvement plan in consultation with parents, school staff, and others. The district improvement plan must meet certain requirements, one of which is implementing strategies to promote effective parental involvement in the district. The district will be implementing the following activities to address the reasons the district has been identified for district improvement: Staff development that includes: *Marzano's Nine Effective Strategies, Math Strategies that Make the Difference, Motivating Students to Greater Heights*, the use of the following software: *TMSDS, Heartbeeps, Study Island; tutorials by teachers, providers, as well as on-line tutoring.*

You may become involved in addressing the reasons the district is identified for improvement by assisting in the following ways: *attending campus PTO's, reviewing your student's attendance and grades on-line, attending parent conferences when requested, and scheduling classroom visits at your convenience.*
