Meeting Date, Time, and Location

The West Oso ISD Safety and Security Committee met on Tuesday, August 6, 2024, in the WOISD Central Office Boardroom at 4:30PM. RJ Alvarado, Executive Director of Safety, Security and Student Services called the meeting to order at 4:32PM. All members of the committee were introduced. Topics presented to the committee included:

1. Introduction of the Sentinel Program in which all safety and security documents for each school district are housed in a central repository for easy access to the state.
2. The new WOISD Parent Code of Conduct which serves to set expectations for the behavior and dress of parents coming to the district.
3. The School Behavior Threat Assessment Process that works to identify threats to the school district to allow time to deal with the threat and prevent tragedy from happening.
4. Review of the District Vulnerability Assessment conducted by the Texas Education State Safety and Security Team. West Oso ISD did very well on the assessment and had very few corrective actions needed.
5. Review of the WOISD Safety and Security Spreadsheet that details all actions taken by the district for safety and security.
